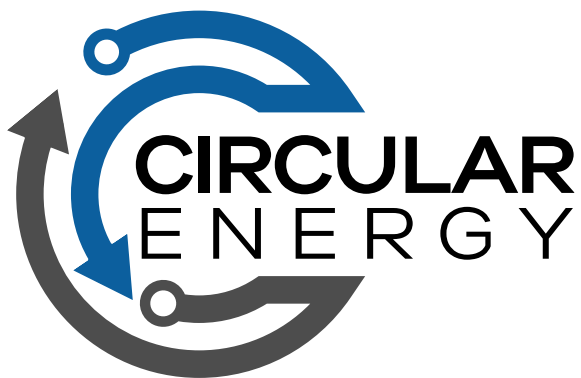

Lighting and Lighting Equipment - 19/7/7/L/PRO/20220808/031;
Paper and Packaging - 19/7/5/P/PRO/20220808/032; and
Portable Batteries - 19/7/5/P/PRO/20230428/039.

Circular Energy NPC's team is trained, qualified, knowledgeable, and experienced to run an effective, professional Extended Producer Responsibility (EPR) scheme.

We assist our producers members in terms of their compliance obligations for the identified products as specified in the Section 18 (1) Sector Notices.

THIS INCLUDES ELECTRICAL AND ELECTRONIC EQUIPMENT, BATTERIES, LIGHTING AND LIGHTING EQUIPMENT AND PAPER AND PACKAGING PRODUCTS.

WHAT DOES CIRCULAR ENERGY NPC DO?

Circular Energy NPC manages a nationwide take-back scheme for the collection, recycling, and environmentally sound management of waste electrical and electronic equipment, batteries, lighting and lighting equipment and packaging in accordance with the S 18 (1) Sector Notices.



VISION AND MISSION

Circular Energy NPC promotes the needs and interests of its members while also supporting the principles of the circular economy. Our overall goal is to achieve zero harm.

WHAT PRODUCTS DOES CIRCULAR ENERGY NPC COVER?

- Traditional generation equipment
- High voltage electrical equipment e.g. transformers
- Product packaging of all types

- Circular Energy NPC has appointed accredited waste management and recycling service providers that are DFFE licensed. This to collect, transport and recover, recycle and treat various waste electrical and electronic equipment products, and their component parts

- We will integrate informal waste collectors, reclaimers, and pickers into the post-consumer collection value chain
- Municipalities, as part of the post-consumer collection value chain, will be integrated
- Circular Energy NPC will submit an interim progress Report to DFFE
- We keep our members' interests in all stakeholder forums a priority; and will invite designated representatives from our members to join these forums
- Circular Energy NPC will submit an annual external audit report to DFFE
